EXECUTIVE SUMMARY

Over the years, the Nigeria Mining Cadastre Office (MCO) has achieved tremendous technological advancements. The Office migrated from the polygonal geometry to cadastre block system; **implementation of a functional manual cadastre**. Then to the development and implementation of a computerized cadastre; **implementation of Version 1 of SIGTIM Title management system**. Then adaptation of the Mining Cadastre to the Nigerian Minerals and Mining Act, 2007 (NMMA), via **implementation of Version 2 of SIGTIM**.

Presently, the Office has successfully implemented a computerized Online Mineral Title administration system; the electronic Mining Cadastre system – eMC+ which is a web-based, real time, online mineral title administration and management system, launched on 1st November, 2022.

The Office has sustained the use of the eMC+, since its installation in December, 2021 hence, by the end of December, 2023, the Office witnessed an exponential increase in both new mineral title and modification application submission, totaling **7,909** (**7,245** new mineral title and **664** modification applications); this in turn, produced a ripple effect, as reflected in the revenue generated in year 2023; to the tune of **N6.071billion**, the highest so far.

The achievements of the Office and implementation of eMC+, has earned the Office prestigious awards such as; the Winner 2022 NIRA.ng award, 2023 NIRA.ng Presidential award, Nigeria GovTech Public Service Award: Best Federal MDA in "Citizen-Centric Online Service" awarded by Bureau of Public Service Reforms – The

Presidency, 2023 all these brings the Office to the forefront of Federal Government Organizations that have achieved digital innovation.

It is worthy, to note that in spite of all the achievements, the use of the new system, was not devoid of challenges; however, the much anticipated upcoming phase II maintenance period, is set to address all pending challenges of the eMC+.

The year under review witnessed the transition of the Government of the Federal Republic of Nigeria, to the present Government lead by His Excellency, President Bola Ahmed Tinubu (GCFR), with the Eight (8) point, Renewed Hope agenda targeted at addressing Nigeria's socio-economic challenges.

President Bola Ahmed Tinubu restructured the Ministry of Mines and Steel Development (MMSD) into two (2) Ministries namely Ministry of Solid Minerals Development (MSMD) and Ministry of Mines and Steel Development (MMSD).

Mr. Henry Dele Alake was appointed the Honourable Minister of Solid Minerals Development and assumed Office on the 21st August, 2023. On that day, he was welcomed to the Office by the Top Management staff of the Ministry along with some Director-Generals of the Agencies under the Ministry.

On the 3rd of September, 2023, the Honourable Minister swung into swift action with a press release on a seven (7) point agenda for the transformation of the Ministry. This was in order to boost the Ministry's international competitiveness and domestic prosperity. Highlight of the press release included: generation of big data on specific seven priority minerals and their deposits; the creation of Mines Surveillance Task Force and Mines Police; comprehensive review of all mining licenses amongst others.

In compliance to the comprehensive review of all mining licenses, the Honourable Minister approved the revocation of a total of 1,619 Mineral Titles, due to non-compliance with their obligations as spelt out in the Nigerian Mineral and Mining Act, 2007 (NMMA).

The Honourable Minister paid a working visit to the MCO on the 21st November, 2023. During the visit, the Director-General (DG) made a presentation of the challenges the Office was grappling with and also practically showcased eMC+ to the Honourable Minister. Highlight of the challenges included:

- a. Delay in processing of Mineral Title Applications due to absence of tools to excise partial overlap,
- b. Missing Titles in the database some of such cases occurred during the process of migrating the database from SIGTIM to eMC+, other cases are as a result of lack of system validation; Titles that where successfully migrated to eMC+ need system validation by Mineral Title Holders, once this validation is not done, the system rejects and removes the License by default.
- **c.** Complexity in the issuance of consent
- d. Title holders unable to file multiple Small Scale Mining Lease's (SSML) on their Exploration License's (EL).
- e. Inability to relate two different points at the same time especially during dispute resolution.

The DG further explained to the Minister, that the Office was liaising with MinDiver and the developers of the software – eMC+, to commence the phase II maintenance period which will address all of the above challenges to enable the effective and efficient operationalization of the eMC+.

The Honourable Minister applauded the achievements of the MCO, however, as the gateway to the mining sector, he admonished the Director-General, to ensure that all the challenges were surmounted in order to restore investor confidence in the sector.

In the year under review, as the gateway to the Mining sector, the Office ensured its participation at both Local and International Mining Conferences, notable amongst which include: Future Mineral Summit – Riyadh, Saudi Arabia, Investing in African Mining Indaba, Cape Town, South Africa, Prospectors and Developers Association of Canada (PDAC), Africa Down Under Conference Perth, Australia, Tianjing Mining Conference, China just to mention a few. At these conferences, mining sector stakeholders are informed and educated about the current developments in the Nigerian Mining sector and encouraged to make Nigeria their next mining destination due to the modalities put in place for the ease of doing business in the Nigerian Mining sector

FIRST QUARTER ACTIVITIES OF THE OFFICE

The year began with the re-appointment of Engr. Obadiah Simon Nkom as Director General of the Nigeria Mining Cadastre Office for a second and final term of four (4) years with effect from 12th January, 2023. He was first appointed on 12th January, 2019 for an initial period of four (4) years.

Attending both local and international mining conferences, serves as a platform, through which the Ministry of Solid Minerals Development (MSMD), enlighten mining sector stakeholders on the progress the Ministry has made in the Nigerian mining sector, emphasizing the fact that Nigeria is indeed a mining destination that is worth venturing to, as such, the Office is part of the Team that accompanies the Honourable Minister MSMD, to these conferences.

In the first quarter of the year under review, International conferences the Office participated at included:

Olamilekan Adegbite with his Team; DG- NMCO, Engr. O. S Nkom; DG NGSA, Dr. Rasaq Garba; PC- MinDiver, Engr. Salim; HM - SSA (Technical) Mr. Olu Adedayo and other VIP Delegates

The State House invited the Director – General to make a presentation on the achievements and operations of the MCO at the 63rd State House weekly press briefing, on the 19th of January, 2023.

The Office also attended the Ministry of Mines and Steel Development Ministerial Retreat held at the Best Western Plus Hotel, Ibadan, Oyo State from Wednesday 25th - Friday, 27th January, 2023.

At the end of the first quarter, total Mineral Title applications received was 1,673, granted 1,529 Licensed 491. While revenue generated was N788,973,000.00

SECOND QUARTER ACTIVITIES OF THE OFFICE

In a bid for the management of MCO to strategize on how best the mandate of the Office can be achieved in the year, the Second quarter of the year commenced with a one-day retreat at the Bon Hotel Elvis, Wuse II Abuja; with the theme **"Repositioning MCO through Attitude Transformation for Improved Productivity"** organized by the Management on the 3rd of May 2023. Resource persons were drawn from the Economic and Financial Crimes Commission (EFCC), Independent Corrupt Practices Commission (ICPC) and the Department of State Services (DSS). The Heads of Departments and Units of the Office also made presentations and anchored breakout sessions.

May 10th 2023, the Director – General received the award of the most outstanding Director – General in the Mining Sector issued by Nigerian Union of Journalist (NUJ)/Federal Radio Corporation of Nigeria (FRCN).

To further buttress the intention of the Retreat held by the Office, to ensure efficiency and transparency in the operations of the Office staff re-shuffling and posting was conducted on the 31st of May, 2023, whereby staff at the HQTS were posted to the Zonal Offices and Vice versa.

The Director-General in company of Management staff, paid a courtesy visit to the newly appointed Permanent Secretary, Dr. Mary Ogbe at the Conference room of MMSD on the 8th June, 2023 and briefed her of the operations, achievements and challenges of the Office.



In the usual manner, the Office attended the Nigerian Extractive Industry Transparency Initiative (NEITI) 2021 Solid Minerals Audit Tripartite Reconciliation meeting between the independent Auditors, Companies & Government Agencies, which held in

Lagos and Port Harcourt from $15^{th} - 19^{th}$ and $22^{nd} - 26^{th}$ May, 2023 respectively.

As outlined in the Terms of Reference for the contract for the Automation and Upgrade of the Nigeria Mining Cadastre Office; the eMC+ maintenance mission week commenced from the $26^{th} - 31^{st}$ May at the MCO HQTRS conference room.

The Office, represented by Engr Mustapha M Yusuf, participated at the Extractive Industry Transparency Initiative (EITI) Global Conference on Beneficial Ownership (BO) transparency, held on the $13^{th} - 14^{th}$ June, 2023 in Dakar Senegal.

The Office also attended the 25th annual Africa Energy Forum (AEF) in Kenya on the 20th of June 2023.

At the end of the second quarter, total Mineral Title applications received was 1,582, granted638; Licensed 730. While revenue generated was N3,083,426,100.00

THIRD QUARTER ACTIVITIES OF THE OFFICE

The Permanent Secretary Dr. Mary Ogbe, embarked on a familiarization tour of the MCO on the 11th July, 2023 and was received by the DG (MCO) Engr. O.S Nkom.

The Executive Governor of Nasarawa State, His Excellency, Engr. Abdullahi A. Sule granted audience to the Director – General, MCO for a courtesy visit at the Government House, Lafia on Friday 21st July 2023.

The new Minister of the Ministry of Solid Minerals Development Mr. Henry Dele Alake was appointed on the 17th August, 2023. He assumed Office on 21st of August, 2023; the Director – General in company of Top management staff of the Ministry was present at the welcoming ceremony of the Honourable Minister, Solid Minerals Development, Mr. Henry Dele Alake, held at the conference room of the Ministry.

In order to brief the new Minister on the functions, activities and achievements of the MCO, the Director-General in company of some management staff visited the Honourable Minister on the 29th August, 2023 to conduct the Ministerial briefing. The Permanent Secretary, Dr. Mary Ogbe, was also present at the briefing.



The Hon. Minister of Solid Minerals Development Mr. Henry Dele Alake, Dr. Mary Ogbe, DG MCO, Engr. Obadiah Simon Nkom and some MCO Management staff at the MCO Ministerial Briefing held in the Minister's Office on Tuesday, 29th August, 2023.

The African Down Under Conference took place at Perth Australia 6th to 8th of September with the attendance of HM, MSMD, Mr. Dele Alake with DG - MCO, Engr. Obadiah Simon Nkom and other delegates.

At the end of the third quarter, total Mineral Title applications received was 1,995, granted 1,136; Licensed 984. While revenue generated was N1,065,854,100.00.

FOURTH QUARTER ACTIVITIES OF THE OFFICE

The 8th edition of the Annual Nigeria Mining week took place from the 16th to 18th October 2023 at the International Conference Centre Abuja, with the Office and other Agencies under the Ministry of Solid Minerals Development in attendance.



The Director – General was awarded as the Distinguished GovTech Trailblazer and MCO honored as best Federal in Citizen online service, at a ceremony held at the International Conference Centre, Abuja on the 13th of October 2023.

DG- MCO, Engr. At the end of the fourth quarter, total Mineral Title applications received was 1,994, granted 892; Licensed 1,210. While revenue generated was N1,133,010,261.00

eMC+ PERFORMANCE SINCE UNVEILING TO MINING SECTOR STAKEHOLDERS

eMC+ was unveiled to mining sector stake holders on the 1st November, 2022. Fourteen (14) months after, there has been a gradual adoption of the system by stakeholders, as shown in the table below:

- 1. Total monthly Mineral Title and modification application submissions = 9,495
- Projection for Unassisted Online Mineral Title and Modification Application
 Submissions = 150 monthly
- Actual Unassisted Online Mineral Title and modification application submissions = 3,706
- 4. Performance against projection = 1,606
- 5. Percentage of performance against projection = 76.47%

At the end of year 2023, adoption of eMC+, by mining sector stakeholders is 39.06% and the percentage actual performance is 76.47%.

The 2024 projection is actually 50% lower than the percentage actual performance of year 2023. A clear analysis, derived from the table above was done that resulted in the 2024 projection for Unassisted Online Mineral Title and modification application submission as 207 monthly submissions.

1.0 INTRODUCTION

The Federal Government's mining sector reform of 2006, brought about the establishment of the Mining Cadastre Office (MCO) as an Agency in line with the provision of section 5(1) of the Nigerian Minerals and Mining Act (NMMA) 2007. The coming into effect of this Act in 2007 saw the transformation of the Office into an autonomous Agency with the responsibility of Administration and Management of Mineral Titles, which is considered to be the cornerstone of a secured mineral right system.

The Nigeria Mining Cadastre Office (referred to in this report as, "Agency") is headed by a Director General. The Organization's structure comprises, four (4) Departments, namely Concession, Registry, Human Resources and Finance, and Monitoring and Coordination, all headed by Directors; Seven (7) Units and Six (6) Zonal Offices with a Zonal Office established in each of the Six (6) Geo-Political Zones of Nigeria. The Seven (7) Units comprise, Information Technology (ICT), Internal Audit, Legal Services, Press, Procurement, Protocol, Research Development and Sustainability (RDS).

The Office has sucessfully concluded the implementation of the Project, titled **"Upgrading and Automation of the Mining Cadastre Office for Online Applications, e-Recording, Archiving and Establishment of Mining Cadastre Offices in the Six Geopolitical Zones",** a mining sector focused reform, executed by the Mineral Sector Support for Economic Diversification (MinDiver) Project; coordinated by the World Bank. Currently at the final maintenance phase.

MCO ORGANISATIONAL STRUCTURE




Fig. 1: MCO Organizational Structure

2.0 MINING CADASTRE OFFICE (MCO) MANDATE

The Mining Cadastre Office shall in addition to other functions prescribed under the Nigerian Minerals and Mining Act, 2007 perform the following functions:

- Receive, consider and dispose applications for mineral titles and permits and applications for the transfer, renewal, modification and relinquishment of mineral titles or extension of mineral title concession areas;
- (ii) Grant, issue, suspend and (with the approval of the Minister) revoke mineral titles;
- (iii) Maintain a chronological record of all applications for mineral titles in a Priority Register and General Register and maintain the cadastral registers;
- (iv) Create and maintain a database of all mineral titles and applications;and
- (v) Create and maintain a cartographic database of all mineral titles and applications in both paper and electronic formats (the cadastral maps).

The current position of the Agency's full implementation of these functions as an autonomous body has resulted into an increase in attraction of Foreign Direct Investment (FDI) into the sector thereby generating substantial revenue to Government.

3.0 MILESTONE ACHIEVEMENTS OF THE MCO IN 2023

In the year under review, the notable achievements of the Office include the following:

- 1. In 2023, the Office generated the highest revenue so far; **N6.071B**.
- 2. 2023 NIRA.ng Presidential Awards
- Nigeria GovTech Public Service Award: Best Federal MDA in "Citizen-Centric Online Service" awarded by Bureau of Public Service Reforms – The Presidency, 2023
- 4. Won all Court cases in the year, 2023.
- Sustained usage of the unveiled new system eMC+ by MCO staff and stakeholders.
- 6. Continuous cleaning of database (due to backlog) and full operationalization moving from SIGTIM programme to eMC+.
- Exponential increase in Mineral Title Application submission by investors in the mining sector
- 8. Participation in Numerous Local and International Mining Conferences such as London Mines and Money, Australia Down Under, Prospectors and Developers Association of Canada (PDAC), Investing in African Mining Indaba, Capetown – South Africa etc. Participation in these conferences has served as a dependable platform for attracting foreign investment to the Mining Sector.

- 9. Revocation of 1,619 mineral titles and implementation of the Revoked titles that have defaulted in terms of payment of their Annual Service Fees and other contraventions of the NMMA, 2007 in the database.
- 10. Deleting of Expired Mineral Titles from the data base.
- 11. Withdrawal of provisional grants not collected.
- 12. Publication of grants of Mineral Titles in both print and electronic media.

4.0 CONCESSION DEPARTMENT

Concession Department is one of the three (3) Technical Departments of the Nigeria Mining Cadastre Office. It is saddled with the following responsibilities, among others;

- i. Receiving, processing, and deposing of application for Mineral titles and permits.
- ii. Record and update receipts of Grant of Initial Service Fee payments on mineral titles.
- iii. Issue mineral titles and permits to qualified applicants.
- iv. Maintain a chronological record of all applications for mineral titles and permits in a priority register which is specifically used to ascertain the registration of the application.
- V. Undertakes such other activities reasonably necessary for carrying out its duties and responsibilities under the provisions of the Act, 2007 and its Regulations, 2011.

This report is a compilation of Applications for Mineral Titles received, granted, and issued in the year 2023. A total of 7,242 applications for Mineral Titles (including Permits) were received in the year under review. Of this number, over 5,000 were evaluated while 2,112 is still pending. 4,195 applications were approved for granting, and 3,591 approved grants were issued while 805 were refused for not meeting up with the requirements of the provisions of the NMMA, 2007 and its Regulations made pursuant to it. A total number of 3,415 mineral titles were signed, and 2,183 were issued.

BAR CHART SHOWING ACTIVITIES FROM JANUARY TO DECEMBER 2023




Fig 2: Bar chart Showing transactions from January to December 2023



Fig 3: Bar-Chart Showing Number of Mineral Titles received on Monthly bases for 2023




Fig 4: Bar-Chart Showing Number of Mineral Titles received by title type on Monthly bases for 2023




Fig 5: bar-chart Showing Number of Grants Issued per month





Fig 7: Bar- Chart Showing Number of Issued Mineral Titles in 2023



4.9 UNITS IN CONCESSION DEPARTMENT

- a. Information Desk: The information desk is the first point of contact with the Office, that handles enquiries and provides information relating to mineral titles and application procedures/requirements in accordance with the Nigeria Mineral and Mining Act, 2007 and its regulation, 2011.
- b. New Application Desk: The new application desk is saddled with the responsibility of receiving and encoding new applications from applicants for mineral titles.
- c. Evaluation Desk: The evaluation desk is the technical section that carries out evaluation, enlargement and processing mineral title applications received.
- d. **Grant/License Desk:** Gives information on Grant/License and also issuance of new grants/licenses to applicants.

5.0 REGISTRY DEPARTMENT

The Registry Department is one of the three (3) technical departments of the Nigeria Mining Cadastre Office (MCO) and is the custodian of all Mineral Title records in the Office. The department is shouldered with the responsibility of record keeping, preparation of Mineral blocks for bidding, and Modification of Mineral Titles (Renewal, Relinquishment, Abandon/Surrender, Consolidation, Transfer, etc.)




Fig 9: Bar-Chart Showing Number of Different types of Applications for Modifications Received in 2023




Fig 10: Bar chart showing Renewal Applications Received and Approved in 2023




Fig. 11: Bar Chart Showing Renewal Applications Received on A monthly basis




Fig. 12: Bar chart showing renewal applications approved on a monthly basis




Fig 13: Bar Chart Showing Transfers Applications Received and Approved in 2023.

5.8 UPDATE ON BITUMEN

In furthering the objective of the economic diversification policy of Government, the Ministry of Solid Minerals Development (MSMD in 2020 renewed its commitment and adopted a strategy that leveraged on private sector participation towards developing the country's Bitumen resources.

2. Government's intention is aimed at ensuring that the Nigeria's Bitumen resources are fully harnessed for domestic industrial and infrastructural development of the country as well as for export purposes.

3. Given the national demand for Bitumen as the main input for asphalt production for road construction and other civil engineering works, and the need to re-invigorate and stimulate investment into the Mining Sector in line with Government's Policy thrust of diversifying the Economy, MMSD in January, 2020 constituted a 9-member Ministerial Committee for the Development of Bitumen Resources (Bitumen Committee). The Committee was inaugurated on the 31st January 2020 by the then Honourable Minister.

4. The Bitumen Committee was chaired by the Director-General, Nigeria Mining Cadastre Office Engr. O. S. Nkom, who was tasked with the overall mandate of determining the criteria for the allocation of the delineated Bitumen blocks and ways of developing the resources to ensure maximum benefit for the country.

5. Nigeria is endowed with large deposits of Bitumen with a reserve estimate of 42 billion barrels which occurs in the Bitumen belt that stretches across Lagos, Ogun, Ondo and Edo States over an area of about 120km by 4km.

6. Given the uniqueness and peculiarities tied to the exploration, development and extraction of Bitumen (Tarsand), the Bitumen Committee observed that the

development of the Bitumen resources requires specialized set of technical activities, as well as huge financial involvement.

7. The Committee noted the need to allocate the delineated Bitumen blocks through a **transparent and competitive bidding process to** only companies that have the requisite experience, technological expertise and financial capacity to adequately carry out the bitumen development to a meaningful extraction level.

8. Consequently, MMSD, based on recommendation of the Bitumen Committee engaged the services of Messrs PricewaterhouseCoopers (**PwC**) in November, 2021 which served as the Transaction Adviser (TA)/ Program Manager for the competitive bidding of the delineated Bitumen blocks to potential investors.

9. In line with the public procurement guidelines, a two-stage bidding process (collectively referred to as the "**Bidding Process**") was adopted based on the recommendation of the TA for the selection of the successful Bidders for award of the Bitumen blocks for development.

10. The execution of bid activities which lasted for the period of 20months (Nov. 2021 – June 2023) was conducted in accordance with the provisions of the Nigerian Minerals and Mining Act, 2007 and the regulations made pursuant to the Act and consistent with international best practices.

11. In all, a total of 21 bidders made 27 bid submissions for 20 sub-blocks, out of the 40 sub-blocks available for bidding. At the end of the bidding exercise, 17 bidders were successful and approved as preferred bidders for the development of Twenty (20) Sub-blocks of Nigeria's Bitumen resource.

12. Upon submitting the report of the Bitumen Committee to the Honourable Minister, Mr. Henry Dele Alake he approved the reconstitution of the Bitumen

committee, to develop the criteria for disposing the remaining unsold Bitumen subblocks, to competent interested investors through competitive bidding process.

13. In addition to the Ministerial Bitumen Committee, the Honourable Minister approved the setting up of a 5-man standing technical committee, to closely monitor the Bitumen resource development activities, by the Companies granted Bitumen Exploration Licenses and Mining Leases and ensure that, the activities are conducted, in line with the provisions of the Nigerian Minerals and Mining Act, 2007 and the Regulations made pursuant to the Act. These Committees are yet to be inaugurated.

14. Furthermore, the Honourable Minister approved that Messrs PricewaterhouseCoopers Limited (PwC) that served as the Transaction Adviser (TA) for first round of the Bitumen block competitive bidding project be retained as the TA for the second round of the Bitumen block competitive bidding project. Messrs PwC has also been invited to attend the inauguration ceremony of the reconstituted Bitumen Committee.

6.0 MONITORING AND CORDINATION DEPARTMENT

6.1 INTRODUCTION:

The Monitoring and Coordination Department (M & C) is one the largest Technical Departments in the Nigerian Mining Cadastre Office. This has become so, as the Department gave birth to Six Zonal Offices, one each located at the six geo-political zones of Nigeria with a mandate to decentralize the activities at the Head Office and create a client-friendly environment for our numerous investors.

6.2 FUNCTIONS OF THE ZONES:

The Cadastre Zonal Offices were created for administrative convenience with the following purposes:

- i. To receive and register mineral title applications which are correctly submitted in a prescribed manner in the States under their zones.
- ii. To receive and register all modifications within their zones
- iii. To receive all form of complaints arising from mineral applications/titles from Companies, Communities and or individuals.
- iv. To handle other functions that may be assigned to them by DG or the Director (M & C).

6.3 ATIVITIES EXECUTED BY ZONES

The activities of the zones are as found in the following reports submitted by the Zonal heads below:

i. South-East: Pages 40 – 43
ii. South-South: Pages 44 – 45
iii. South-West: Pages 46 – 50
iv. North-East: Pages 51 – 53

- v. North-Central Pages 54 56
- vi. North-West: Pages 57–60

The statistics of the Zonal Offices' activities are imbedded in their respective reports. It is however, observed that while some of the Zonal Officers took statistics of the activities in the zone, others lumped it in their general report.

CONCLUSION

The full take-off of the Zonal Offices shall be an avenue for providing ease of doing business in the mineral title administration to the grass-roots hence, its importance cannot be over-emphasized.

6.2.0 SOUTH-SOUTH BENIN ZONAL OFFICE

The South-South Zonal Office, Benin had a busy year 2023 as the Office was able to register applications, carry out resolution meetings, confirmation of consents, andattend workshops and sensitization meetings. Details below The Benin Office registered a total of 72 applications for various mineral titles, this includes:

- 17 Exploration Title Applications
- 1 Reconnaissance Permit
- 6 Quarry Lease Applications
- 48 Small Scale Mining Lease Applications

The Office received letters from the head Office in Abuja on various occasions, these letters were often disclaimers and complaints from applicants, title owners or Host communities where the mining activities are carried out.

The Benin Office responds to these letters by calling the parties involved, scheduling a meet and in most cases travel down to the host communities to confirm originality of the consent presented by applicants. The reports and findings from each meeting are transmitted back to the Head Office.

The Zonal Office sent her staff to Abuja for a workshop titled R2D "Repositioning for Development" sometimes in May 2023, the workshop was to prepare all the staff of the Office for the task ahead and as well as know the challenges faced at the various Zonal Offices.

Furthermore, the Office was invited on several occasions by the Edo State

government to sensitize the miners and stakeholders in the state on how to apply for mineral titles, how to settle disputes amongst themselves and ultimately the way forward for the state as regards mining.

The Office received a face lift as blinds, long chair for visitors, a fridge and an air-conditioner were supplied during the year.

The Office is gradually fulfilling her purpose and is confident of a better working year 2024.

6.3.0 SOUTH-WEST IBADAN ZONAL OFFICE

A total of 32 Cases were handled and treated in the Zone in the year under review, below are the breakdown.

6.4.0 NORTH-EAST MAIDUGURI ZONAL OFFICE

6.4.1 Staff Strength and Commitment

The North-East Zonal staff are four in number. These includes the Zonal Head, Administrative Officer, a Surveyor and driver. The Staff are all punctual and committed to work.

To meet the desired target upon which the Office is being established, there is urgent need to deploy more staff because presently the staffs are limited in number.

6.4.2 Existing Office Facilities/Equipment

- i. **Office Vehicle:** The Office vehicle (Hilux) is in good working order except the four tyres and battery that call for change and the need for general servicing and fuelling the vehicle.
- ii. The 25KVA installed generator is in good working order but the battery is no more working. There is need for a new one.
- iii. **Solar Batteries and Panels:** Due to ongoing renovation of the entire Office complex, some of the panels are transferred temporary to the nearby roof while others are kept pending the completion of the renovation. However, all the batteries and panels are perfectly working.

The renovation contractor has requested for change of iron rod to aluminum rod because the contact of iron rod upon which the solar panels are laid upon now is creating rusting effect thereby damaging the aluminum zinc. MCO/Mindiver is urged to take a good measure.

- iv. **Computer System and printers** are in good order except the continuous need for system upgrade and update.
- v. Furniture: All the furniture are in good order

6.4.3 New Facilities/Equipment

Besides the existing facilities, there are also new facilities supplied to the Office by MCO/MINDIVER through the contractor. These facilities/equipment include the following:

The facilities supplied above are presently in good order.

6.4.4 Office Activities

The Office activities are going on smoothly. However, considering the security challenges confronting the zone particularly in the past, but as peace is being restored now in most of the areas, we believe, very soon activities will rise to the greater height, even as there is continuous sensitization and awareness on the Office existence and its functions.

6.4.5 One Day Retreat Organized by the Head Office

Three staff of the zone as nominated by the management participated in the one-day retreat organized by the Head-Office on 3rd May, 2023, at Bon-Elvis Hotel Abuja. The retreat was aimed at equipping entire staff targeted at moving Mining Cadastre Office forward.

6.4.6 eMC⁺ and Network Instability

This year, the Office experienced poor and unstable network thereby affecting the use of eMC⁺ which totally rely on network availability.

There is urgent need for an I.T expert who will mediate in arresting such kind of challenges. We strongly appeal for intervention.

6.4.7 Correspondence/Email

Most of our correspondence is channels through emails. Presently we no longer receive messages via this email. There is urgent need for email reactivation.

6.5.0 NORTH-CENTRAL JOS ZONAL OFFICE

The North-central Zonal Office has experienced a gradual influx of activities ranging from inquiries about mining sites as well as applications for Mineral titles, conflict resolutions and other official activities.

The Zonal Office is up and running but not without challenges that have really affected the mode of operations and official activities. In spite of all these, we have remained resilient and determined to ensure the aims and objectives of the Zonal Office is achieved, which is principally to bring services to the door steps of stakeholders.

7.0 HUMAN RESOURCE, FINANCE AND ACCOUNTS

The Department of Human Resource & Finance is one of the four (4) Departments in the Agency. The Department is divided into two (2) Divisions; Human Resource and Accounts.

A. THE HUMAN RESOURCE DIVISION

The Human Resource Division is saddled with the responsibilities of Appointment, Promotion and Discipline. The Division also handles staff welfare with respect to Health, Training, Sporting/Union activities, Pension and any other related matters as may be assigned by the authority.

7.1 **APPOINTMENT**:

There was no recruitment of new staff in the year 2023 but the Office was able to secure from the Head of Civil Service of the Federation (HCSF) the revalidation of waiver for Thirty-Nine (39) positions and another Twenty-Five (25) Nos. waiver to recruit new staff;

- ii. Secured Authorised Establishments of 169 positions for year 2023;
- iii. Secured additional/inclusion of over N40,000,000.00 in 2023Personnel Budget to cater for the proposed 40 staff recruitment.

7.2 STAFF STRENGTH:

Number of Staff at the Head Office is 125 and Number of Staff at the Zonal Office is 44. Total Staff strength is 169.

7.3 **PROMOTION:**

MCO conducted promotion interview for Seventeen (17) Officers. Three other Officers were also converted from Technical to Officers cadre.

7.4 DISCIPLINE:

No disciplinary action was taken against any staff in the year, 2023.

7.5 **POSTING/RETIREMENT:**

Three (3) number of Officers, were posted to MCO: (HR&F/Legal Department). The D(HR&F) Mr. Ladan Mustapha was posted out while Mr. Abraham Oloruntoba, DD(Admin) retired meritoriously from the service. Their repatriation allowances have been paid and the retirees were recognised and honoured by the Director General. We also lost a staff Director Concession Department - Ahmed Damagun.

7.6 SALARY/VARIATION/INCREAMENT:

Salary variation and increment in respect of the staff promoted were respectively carried out. The staff salary for the Month of October, 2023 is still, yet to be paid.

7.7 STAFF WELFARE:

Welfare of Staff members and other supporting staff were adequately taken care of throughout the year.

7.8 TRAINING:

Majority of staff could not attend Training due to paucity of funds. However, the Management approved the participation on the Mandatory Training of Workforce Development, programme of Head of Civil Service of the Federation. The management also approved a number of study leave both local and international to boost the human capacity development of staff.

7.9 PENSION MATTERS:

Pencom approved a Desk Officer for MCO, who will facilitate Pension administration of retirees.

7.9.1 ANTI CORRUPTION TRANSPARENCY UNIT (ACTU):

ICPC assigned a desk Officer for MCO to oversee the anti-corruption activities of the agency. The ICPC visited the Agency and ACTU assessment of the Office was conducted.

7.9.2 FACILITY MANAGEMENT:

FUMIGATION: The Offices were fumigated twice in the year under review, in compliance with AEPB Act, 2010. Furthermore, the two (2) rusted galvanized waste bins were replaced with new ones.

RENOVATION: Some renovation works were carried out, which gave room for the creation of more Offices in the main building.

B. ACCOUNTS DIVISION

The Accounts Division is saddled with the responsibilities of recording, analysis and reporting of financial transactions of the Office. The Division also ensures that all revenue generated by the Office is remitted on a monthly basis, to the Ministry of Solid Minerals Development (MSMD) – Federation Account.

7.9.3 OPERATIONAL ACCOUNTS:

The operational accounts of the Office are Capital, Recurrent (Overhead and Personnel) and Revenue; while budget releases concerning Capital and Overhead accounts, resides with the Central Bank of Nigeria (CBN) and can be accessed through GIFMIS. The administration of Personnel is the exclusive responsibility of Integrated Payroll and Personal Information System (IPPIS). All revenue (with the exception of Internally Generated Revenue (IGR) which is remitted to Federation Account (FA).

12.0 INFORMATION, COMMUNICATION TECHNOLOGY (ICT) UNIT

The ICT Unit is the Hub of the Nigeria Mining Cadastre Office, right from the establishment of the Agency. The Unit has been a technical service unit ensuring the smooth flow of work.

12.1 SOME OF THE FUNCTIONS PERFORMED BY THE UNIT INCLUDE BUT NOT LIMITED TO:

- a. Maintenance of computer system and other electronic devices
- b. Expanding means of communication: phone, email, video conferencing, social media
- c. Data collection and management
- d. Customer Relations Management/Dissemination of Information
- e. Improvement of Processes
- f. Network installation, configuration, management
- g. Software installation, configuration, management
- h. Hardware installation, maintenance, management, troubleshoot/repair
- i. Server/database administration and control
- j. Web resources/content management such as the Nigeria Mining Cadastre Office website, webmail, eMC+
- k. Social media platform management such as Facebook, Instagram, and Twitter accounts.

12.2 THE FOLLOWING ACTIVITIES WERE CARRIED OUT BY THE ICT UNIT IN THE YEAR 2023:

i. REDESIGNING OF THE MCO WEBSITE

The ICT Unit supervised the redesign of the Nigeria Mining Cadastre Office official website, which is now completed and currently up and running. The website is being managed and updated with the latest events in the Office by the unit, along with social media accounts.

ii. INSTALLATION OF COMPUTERS AND PRINTERS

New computers where installed in Accounts units, and also new Multi-Functional Printers (MFP's), were installed in some Offices. This is to ensure best quality print production that will aid, the smooth running of the Nigeria Mining Cadastre Office since printing is an integral part of the Office daily process.

However, there is urgent need to procure more computer systems, printers, toners and computer accessories to meet up with the current demand of the Office.

iii. eMC+ MAINTENANCE UPGRADE

In collaboration with GAF AG Consultant Company, MinDiver and the MCO, ICT successfully had a maintenance period review with GAF AG representative to perform an in-house review of the eMC+ system in order to get the new functional requirements to include in the new update. During and after these maintenance period, observations were made by the stakeholders and staff and these were relayed back to GAF AG for implementations. This update is currently ongoing and is being rolled out periodically. The ICT Unit also identified bugs on the eMC+ and fixed it.

iv. **BANDWIDTH**

We have successfully increased our bandwidth from 20MbPermanent Secretary to 40MbPermanent Secretary at the Headquarters and also currently working on that of the Zonal Offices. The aspect of system downtime or slow connectivity has been relatively reduced.

v. DATA CLEANING EXERCISE

Through the year, ICT has been actively involved in the process of data cleaning and synchronization to ensure the MCO database is free from anomalies, errors and inconsistencies during the use of the eMC+ system.

vi. POST-LAUNCHING OF EMC+ FOR ONLINE CADASTRE SYSTEM

The ICT Unit ensured the smooth running of the eMC+ by participating actively in the entire process of staff user account creation, configuration, error troubleshooting and reporting.

vii. PUBLIC USER ACCOUNT REGISTRATION

After the successful launch of the eMC+ system, the ICT Unit has been receiving a lot of requests for user accounts registration from public users both online via email and as well physical walk-in into the Office.

viii. CORRESPONDENCE WITH GAF AG CONSULTANT COMPANY

The ICT Unit has been actively communicating with the GAF AG concerning observations made on the use of the eMC+ and to ensure a proper configuration and integration of services required. In the events of server downtime, they assisted in restoring normalcy to the system by walking the system administrators through the process. They also collaborated with Layer3 for the smooth running of the system.

ix. REPLACEMENT OF INVERTER BATTERIES AND SOLAR PANELS

The Unit supervised the replacement of inverter batteries and damaged solar panels by MinDiver and also the purchase of two new inverters, to replace the old ones.

x. INSTALLATION OF HARDWARE AND SOFTWARE

The Unit carried out installation of some computers, printers, software, Microsoft Windows OS & Office, network switches, access points etc., in some Departments and Units.

The unit also carried out maintenance and repair of some computer systems in some Units and Departments.

xi. COLLABORATION BETWEEN MCO, LAYER3 AND GALAXY BACKBONE CONNECTIVITY TO PROVIDE BACKUP (FAILOVER) SERVER.

MCO is currently working out modality with Galaxy Backbone and Layer3 to provide a secondary host. This is currently on-going.

 Insufficient work tools such as file jackets and other stationaries for adequate filing of application documents.
 Disruption of workflow on eMC+ due to inadequate internet bandwidth.
 Insufficient computers (desktop/laptops) and printing machines.
 Inadequate space for filling-cabinets.
 Inadequate proper civic amenities and facilities
 Housing the power-generating set in some Zonal Offices
 Water supply and storage in some Zonal Offices
 Fortifying the Offices' burglary proofs in some Zonal Offices
 Lack of Revenue receipt at the Zonal Offices
 Lack of still and video camera, drone camera and midgets


